ABILITY LEVELS: *(The swimming and water safety programs are for children aged 3 years and over)*

	LEVEL
Beginner - MUST BE AT LEAST 3 YRS OF AGE	1 - WHITE
Able to submerge fully, push off, kick and glide for 2 metres unaided, kick on back with a kickboard	2 - RED
Can swim 5m of freestyle arms and 5m of backstroke	3 - ORANGE
Can swim 7m of freestyle with breathing, 7m of backstroke and breaststroke kick	4 - PURPLE
Can swim 10m of freestyle bi-lateral breathing, 10m of backstroke and 5m of breaststroke	5 - PINK
Can swim 25m of freestyle bi-lateral breathing, 25m of backstroke, 10m of breaststroke and 25m dolphin kick	6 - ROYAL
Can swim 50m of freestyle and backstroke, 25m of breaststroke and 10m of butterfly. Tumble turn and dive	7 - L/BLUE
Can swim 75m of freestyle and backstroke, 50m of breaststroke and 15m of butterfly. All tumble turns and dive	8 - GREEN

PLC Aquatic Centre Collection Notice - A requirement of the Australian Privacy Act

The PLC Aquatic Centre collects personal information, including sensitive information about students, parents and other adults, during the course of a student's enrolment at the College, and in the case of adults, while a patron of the PLC Aquatic Centre. The primary purpose of collecting this information is to enable the Aquatic Centre to provide a recreational service to you. This includes satisfying the needs of any club, association or swimming organisations to which we are affiliated. Some of the information we collect is to satisfy legal obligations, particularly to enable the Centre to discharge its duty of care. Certain laws governing or relating to the operation of the College require that certain information be collected. Health information is sensitive information within the terms of the National Privacy Principles under the Privacy Act. We require medical reports about patrons from time to time. If you do not consent to us obtaining this information we may not be able to enrol or continue your enrolment. The PLC Aquatic Centre from time to time has to disclose certain personal information and sensitive information to others, including the College, other Clubs, medical practitioners, and people providing services to the Centre, including specialist visiting teachers (sports), coaches and volunteers. Patrons may seek access to personal information collected about them and their son/daughter by contacting the Centre. However, there will be occasions when access is denied. Such occasions would include those where the release would have an unreasonable impact on the privacy of others or where release may result in a breach of the Centre's duty of care to the student or patron. If you provide the Centre with the personal information of others, you should inform them that you are disclosing that information to the Centre and why, so that they can access that information if they wish. The Centre does not usually disclose this information to other parties.
