### PLC Aquatic Centre Collection Notice - A requirement of the Australian Privacy Act

The PLC Aquatic Centre collects personal information, including sensitive information about students, parents and other adults, during the course of enrolment at the College, and in the case of adults, while a patron of the PLC Aquatic Centre. This includes satisfying the needs of any club or association of swimming organisations with which we are affiliated. The primary purpose of collecting this information is to enable the Aquatic Centre to provide a recreational service to you. Some of the information we collect is to satisfy legal obligations, particularly to enable the Centre to discharge its duty of care. Certain laws governing or relating to the operation of the College require that certain information be collected. Health information is sensitive information within the terms of the National Privacy Principles under the Privacy Act. We require medical reports about patrons from time to time. If you do not consent to us obtaining this information we may not be able to enrol you or continue your enrolment. The PLC Aquatic Centre from time to time has to disclose certain personal information and sensitive information to others, including the College, other clubs, medical practitioners, and people providing services to the Centre, including specialist visiting teachers (sports), coaches and volunteers. Patrons may seek access to personal information collected about them and their son/daughter by contacting the Centre. However, there will be occasions when access is denied. Such occasions would include those where the release would have an unreasonable impact on the privacy of others or where release may result in a breach of the Centre's duty of care to the patron. If you provide the Centre with the personal information of others, you should inform them that you are disclosing that information to the Centre and why, so that they can access that information if they wish. The Centre does not usually disclose this information to other parties.
